



SELF—EMPLOYMENT INCOME AND EXPENSE TRACKER

If you are self-employed this worksheet is designed to help you track your income and expenses for your job—NOT YOUR HOUSEHOLD. This means taking your total monthly earnings and subtracting your total monthly expenses for your job—NOT YOUR HOUSEHOLD.

Tracking your income and expenses month by month will help Habitat calculate your total income.

As a Partner Family Homebuyer AND an applicant you **MUST TRACK YOUR INCOME AND EXPENSES EVERY MONTH.**

Examples of expenses include:

- **TAXI DRIVERS:** gas, car maintenance, car repairs, auto insurance, leasing fees, **mileage**, etc.
- **HOUSE CLEANERS/MAIDS:** cleaning supplies, insurance, gas, etc.
- **CONSTRUCTION/LANDSCAPE WORKERS:** supplies, tools, licensing fees, gas, etc.
